QUESTIONS:

1. Climate Emergency Office: rely on Office of Sustainability or create new Climate Emergency Office?
2. Public Transport – facilitate private transport or support clean-energy public transport?
3. 100% Renewable Energy: 50% renewables by 2030 or 100% by 2050>
4. Climate over Growth: Support actions to fight climate change so long as they don't compete with growth or Prioritize action to fight climate change
5. Close Dickerson: Support keeping Dickerson in operation or close Dickerson plant.
6. Fossil Fuel Divestment: Support keeping fossil fuel companies in County portfolios or support Bill 44-16.
7. Green Spaces: Support development over keeping green spaces or Fight to preserve green spaces for carbon drawdown.b
8. Price on Carbon: Oppose price on carbon or support price on carbon, with dividends returned to MoCo citizens
9. Residential/Commercial Renewable Energy: Rely on market to bring clean energy to residential and commercial properties or use policy to promote this.
10. Carbon Drawdown: Support recovering green areas if there is no conflict with growth or promote more green spaces for carbon drawdown.
